Within the text, references should be cited in numerical order according to their order of appearance. The numbered reference citation should be enclosed in brackets. In the case of more than two references, the numbers should be separated by a dash []. References to original sources for cited material should be listed together at the end of the paper; footnotes should not be used for this purpose. References should be arranged in numerical order according to the sequence of citations within the text. Each reference should include the last name of each author followed by his initials.
