Chapter 2 : Car Selling Contract

The vehicle purchase agreement/vehicle contract is an agreement for the sale and purchase of the car or some other vehicle. "Vehicle purchase agreement" is thus a general term and it might refer to several different types of purchase agreements, so long as types concern the sale of the car.

Payment Agreement Template PandaTip: The Owing Party agrees and acknowledges that it owes the Owed Party an amount of money equal to the Deficiency as defined above. Here, we have the Owing Party acknowledging that the Deficiency exists and that even though this Payment Agreement is being executed, there is nothing inherent in such agreement that takes the Owing Party off the hook other than making payments according to the plan. The Owing Party hereby represents and warrants that this Agreement and the payment plan herein has been developed in a manner that that the Owing Party reasonably believes it can pay the Owed Party without further interruption notwithstanding an additional change in circumstances. Here, the Owing Party is affirming that it has the ability to pay according to the payment plan laid out in this Payment Agreement. This is useful to the Owed Party as it protects it from the Owing Party just entering this Agreement to get the Owed Party off its back as if the Owing Party is doing so, then it is evidence of bad faith, which can result in further damages in litigation should it get to that point. It does, however, in the interest of fairness include an exception for a material change in circumstances. The Owing Party agrees to make the payments to the Owed Party associated with the dates as listed on the Payment Plan. It is important to note here that the amount required should simply amount to the Deficiency owed. In the event that penalties or interest are added, a whole other set of rules comes into play. The Owed Party can specify whatever method by which it wants to be paid, whether by cash, PayPal, bank transfer, wire, etc. In consideration for agreeing to this Payment Agreement, the Owed Party hereby releases any claims against the Owing Party related to the Deficiency as of the date of this Agreement. However, nothing in this Agreement is meant to release the Owing Party from its obligation to pay the Deficiency according to the Payment Plan herein or limit the rights of the Owed Party in collecting said Deficiency. The purpose of this section is to allow the Owing Party to make the payments without concern that it will get sued for the Deficiency as long as it adheres to this Payment Agreement. In the event that the Owing Party fails to make any payments in accordance with the Payment Plan, upon reaching ten 10 days after the failure to make any such prescribed payment, the full amount of the Deficiency shall come immediately due and payable. This gives the Payment Agreement some teeth. If the Owing Party fails to make a payment for ten days, then the total amount accelerates, leaving the Owing Party with a much bigger bill to pay. In the event of such assignment, the assignee may designate a new method of payment. This clause gives the Owed Party the ability to transfer payments to some other third party and allows that third party to change the method of payment, but everything else regarding the Payment Agreement should remain effective. No modification of this Agreement shall be valid unless in writing and agreed upon by both Parties. In the event any provision of this Agreement is held to be invalid, illegal, or enforceable for any reason, then the Parties agree that such provision shall be deemed to be struck and the remainder of the Agreement shall be enforced as if the struck provision were never included in the Agreement.

A payment contract is a document generated through writing that consists of an agreement deemed to be binding between parties who, in their capacity to consent, agreed to pay a certain amount of money to whom they have made transactions with.

Draw up a contract stating the terms of the sale or have a lawyer do this for you. It should include information such as the price of the car, a schedule of installment payments -- including the date by which the car should be paid in full -- and the amount of each payment. If you prepare the contract yourself, have a lawyer review it to make sure it contains all necessary information so each party is protected. Give a copy to the buyer. Prepare the documents necessary for a vehicle sale in your state. Some states use a bill of sale in addition to a transfer of the title. Keep a copy of the documents for your records. Finalize the Deal Transfer the title of the car to the new owner after receiving the initial payment. Report the sale to the DMV so that you are not responsible for anything to do with the car in the future, such as parking tickets or other citations. If the buyer does not honor it, you can use it to make a case against the buyer in court and receive the rest of your money.
