Many organization health care providers who apply for NPIs are not legal entities themselves but are parts of other organization health care providers that are legal entities the "parents". Here are three examples of organization health care providers that may be considered subparts and may apply for NPIs if so directed by their "parents": The legal entity must obtain an NPI. The psychiatric unit is an example of a subpart that could have its own NPI if the hospital determines that it should. The offices are examples of subparts that could have their own NPIs if the main location determines that they should. Neither the pharmacy line of business nor the DME line of business represent legal entities; instead, both lines of business are part of an organization the "parent" that is a legal entity. Each line of business represents a different Healthcare Provider Taxonomy or area of specialization that often submits its own electronic claims to health plans.
